## Indiana's Smoke Free Air Laws

There are 42 municipalities in Indiana covered by some local smoke free air law.

Indiana's statewide smoke free air law, House Enrolled Act 1149, took effect July 1, 2012.

24 communities plus the Indianapolis International Airport have passed a smoke free air law that includes non-hospitality workplaces, restaurants, and bars with 17 of those also including membership clubs in their local ordinances.

## Indiana's Smoke Free Air Laws

Five Indiana communities have passed smoke free air laws that mostly include non-hospitality workplaces and have exemptions that do not follow the recommended guidelines outlined by the Surgeon General for protecting citizens from exposure to secondhand smoke. These laws were passed prior to the statewide smoke free air law. Smoking is no longer permitted in restaurants and most workplaces in these communities.

Indiana Communities with Laws that ONLY include Non-Hospitality Workplaces and/or allow for restaurant exemptions. Bars are also exempted.
